Know all persons by these presents that the undersigned hereby makes, constitutes and appoints Seth Weisberg, Matthew A. Lipson, Sara Kani, Juliet Stone and David M. Zlotchew as the undersigned's true and lawful attorney-in-fact, each with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned:
